Summary

- **SRF** – Social risk factor.

Cohort descriptions

- **BOTH_FULL** – Member’s with disability and low-income subsidy.
- **CONTROL** – The control group; Medicare members without SRF’s.
- **DISABILITY_ONLY** – Presence of only the disability SRF.
- **DIS_OR_LIS** – Presence of either the disability or low-income subsidy SRF.
- **LIS_FULL_ONLY** – Presence of only the low-income subsidy SRF.
- **Overall** – An aggregate of all the cohorts listed above.



Column names

- **Approval_Rate** – Approval rate.
- **Denial_Rate** – Denial rate.
- **Extension_Rate** – Percent approved after extension.
- **Appeal_Rate** – Percent approved after appeal.
- **MED_Decision_HRS** – Median decision time in hours.
- **AVG_Decision_HRS** – Mean decision time in hours.
